

APPLICATION FOR REGISTRATION OF CONTRACTORS
VILLAGE OF FAIRPORT HARBOR, LAKE COUNTY, OHIO

Application is hereby made for a Contractor Registration, in accordance with Chapter 1321 of the Codified Ordinances of the Village of Fairport Harbor. No person, firm, or corporation shall engage in the business or act in the capacity of a contractor without conforming with the provisions of Chapter 1321 of the Codified Ordinances of the Village of Fairport Harbor. All persons, prior to engaging in or being employed as responsible for the installation, replacement, and/or construction within the Village shall obtain the required certificate of registration. It is understood and agreed by the applicant, that any error, misstatement, or misrepresentation of fact, either with, or without intention on the part of the applicant, shall constitute sufficient ground for revocation of this permit at any time. All provisions of the Lake County Building Codes, Lake County Health Department, Village of Fairport Harbor Fire Department, and the Village of Fairport Harbor Planning, Zoning, and Building Codes shall be followed. This Registration shall expire on December 31st of the calendar year in which application is made, and shall not be transferable to any new owner.

General: No applicant shall be registered unless (1) is at least eighteen years of age , (2) is of good moral character, (3) has been previously engaged in the applicable trade for a minimum period of two years; provide a chronological list of projects (4) HVAC, Hydronic, Electrical, and Plumbing Contractors must provide State License Number.
